

Use of Vehicles in Activities of Reach High Scholars Program

The Reach High Scholars Program (the "RHSP") helps to plan trips to colleges and college fairs ("College Visits") for students from Raymond High School ("RHS").

This form is to be completed by the owner (the "Owner") for each private vehicle (the "Vehicle") expected to be used for College Visits by the drivers listed below, each of whom must be at least 21 years of age (each a "Driver"). The form is valid for the school year in which filed. A new statement must be submitted during the school year (i) with information on any additional Driver, (ii) if the Vehicle is replaced by another vehicle or (iii) if the insurance policy expires or is canceled.

The Owner agrees as follows:

1. None of the Drivers has been convicted of (i) driving under the influence of alcohol or any other controlled substance or (ii) a moving traffic violation in the past five years.

2. Each RHS student passenger must have a signed *Liability Release Agreement and Parent Permission for Student to Participate in Activities of Reach High Scholars Program* delivered to the RHSP prior to allowing the passenger to be on the College Visit.
3. The Owner's insurance is the primary coverage in the case of an accident in which the operator of the Vehicle is liable for bodily injury or property damage.
4. The maximum number of passengers in the Vehicle must not exceed the number of seat belts in the Vehicle and all passengers must wear seat belts at all times while traveling.
5. While driving or allowing the Vehicle to be used on a College Visit, the Owner releases, relieves, discharges and holds harmless the RHSP, its directors, officers, employees, volunteers and agents from any and all liability or claim of liability, whether for personal injury, property damage or otherwise, arising out of or in connection with the Owner or the Vehicle participating in a College Visit.
